TERMS & CONDITIONS

Between Thunder All Star Cheerleading Inc. ("Thunder") and Parent (defined below). The registration, Payment Schedule, and the Terms and Conditions constitute the agreement between Thunder and Parent ("Agreement").

1. ILLNESS, INJURY, ABSENCE.

1.1. Thunder has two types of absences, excused and unexcused:

1.1.1. Excused. The following circumstances are considered excused absences:

1.1.1.1. Contagious Illness.

1.1.1.2. Vomiting/diarrhea.

1.1.1.3. Fevers over 101.

1.1.1.4. Conflicting school functions that will affect grades, excluding extracurricular activities.

1.1.2. Unexcused. Any circumstance not listed in sec on 1.1.1.

1.2. Athletes that do not have the circumstances listed in sec on 1.1.1 shall a end practice to observe and learn.

1.3. If the Athlete cannot a end a practice for any reason, including excused absences, Parents shall directly contact the Athlete's team coach via telephone before 3:00 pm the day of the scheduled practice or ASAP.

2. COMMUNICATION. Thunder shall communicate with the Athlete and Parent using email. Parent shall maintain a current email address with

Thunder. Thunder uses emails to communicate with the Parent or Athlete or both on a weekly basis with updates and information related to Thunder or the Athlete or both.

3. POLICIES; MEETINGS; PRACTICE.

3.1. Policies. Athlete or Parent, or both, violating Thunder's policies can result in Athlete being dismissed from Thunder. See Thunder's policies for more information.

3.2 Meetings. Parents shall not schedule meetings, hand out letters or flyers, send gym emails, create team Facebook pages, schedule a fundraiser, or purchase wearable items for the teams without prior written permission of Thunder.

4. PRACTICE.

4.1. *Change*. Thunder may, in its own discretion, change practices throughout the season.

4.2. *Attendance*. Parent shall ensure that Athletes attend practices on time. Failure of Athletes to a end practices may, at Thunder Elite's sole discretion, result in their dismissal from Thunder.

4.3. *Gear*. Athletes shall wear the appropriate assigned practice gear. If the appropriate gear is not worn, Thunder will provide one and charge the cost to the Athlete's account.

5. COMPETITION.

5.1. *Attendance*. Athletes shall attend all assigned team competitions. Thunder may, in its sole discretion, expel any Athlete not attending any scheduled competition or event from Thunder.

5.2. *Uniform*. Athletes shall stay in uniform the entire day while at a competition. Athletes shall not wear flip flops, fleece pants, pajamas, and sweatshirts while attending a competition, event, or both. No athletes will be permitted to walk around in blankets or slippers. Athletes are to remain with a professional attire.

6. RISK; DANGEROUS MANEUVERS; SAFETY; ACCIDENTS; RELEASE; INDEMNIFY; PHOTOGRAPH AND VIDEO.

6.1. *Risk*. Parents and Athletes (collectively, "Participants") understand that cheerleading activities ("Activities") are inherently dangerous and might potentially cause severe physical injuries, including permanent paralysis, and death. Parent being fully aware of these dangers, voluntarily consent to the Athlete participating in any and all Activities and accept all risks associated.

6.2. *Dangerous Maneuvers*. Athletes shall not use, perform, or participate in any dangerous or illegal maneuvers.

6.3. *Accidents*. Participants shall immediately report any accidents or injuries to Thunder.

6.4. *Safety*. Athletes shall not wait outside Thunder facilities for their Parents. Athletes shall wait in the gym or lobby area. Thunder is not responsible for Athletes once they have left the Thunder facility. Parent shall pick up Athletes promptly from their practice.

6.5. *Release*. In consideration for allowing the Athlete to participate in the Thunder program, Parent on behalf of himself, the Athlete, and any spouse, theirs, parents, assigns, legal representatives, releases and forever discharges Thunder, and any affiliated companies, members, principals, predecessors, successors, parents, subsidiaries ("Released Parties"), and assigns, from any and all claims, defenses, obligations, known and unknown, past and present, whether arising in contract, tort, or otherwise, whether or not actually asserted, that does or might exist between the Thunder and the Athlete or Parent or both related to the Athlete participation in the Thunder program.

TERMS & CONDITIONS

Between Thunder All Star Cheerleading Inc. ("Thunder") and Parent (defined below). The registration, Payment Schedule, and the Terms and Conditions constitute the agreement between Thunder and Parent ("Agreement").

- 6.6. **Indemnify.** Parent shall defend and indemnify the Released Parties from and against any and all claims, demands, actions, and causes of act on, whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by the Athlete or any property belonging to the Athlete while participating in the activities or while in, on, or about the premises where the activities are being conducted.
- 6.7. **Photography and Video Release.** Participant hereby grants Thunder the right to take photographs and video of the Athlete while participating in the activities, and to use such photographs and video for any lawful purpose, including advertising and marketing.
7. **LOCAL, STATE, AND FEDERAL LAWS** *Local, state, and federal laws.* Athletes may be, at Thunder's sole discretion, expelled from Thunder if they violate any local, state, or federal laws.
8. **ALCOHOL, DRUGS, AND TOBACCO.** Thunder prohibits the use, possession, sale, or distribution of any controlled substances, alcohol, marijuana, or tobacco by Participant in any Thunder competition, practice, event or facility.
9. **LIKENESS.** Without prior permission from Thunder, Thunder prohibits the use of any image, likeness, logos, or team names of or related to "Thunder Elite" or "Thunder All-Star Cheerleading" or both (collectively, the "Logo"). Participants shall obtain prior written permission before producing or selling, or both, any products that use or display the Logo.
10. **FUNDRAISING.** Participants shall not use the Logo to run their own fundraiser.
11. **TUITION; INTEREST; TERMINATION FEE.**
- 11.1. **Tuition.** For the Duration listed in the Payment Schedule ("Duration"), Parent shall pay the team's Rate selected in the Payment Schedule (the "Rate") no later than the 1st day of each month. Parent shall provide a VISA or MasterCard, and hereby grants Thunder the permission to charge their credit or debit card the Rate for the Duration by the 1st day of each month. If Parent does not want their credit or debit card to be charged, then they must pay the Rate via cash or check no later than the 1st day of each month for the Duration.
- 11.2. **Interests; Late Fees.** For any amount due that remains unpaid after its due date, interest will accrue at 18% per annum, compounded monthly. Additionally, Thunder may charge a \$50 fee for any returned checks or refused charges.
- 11.3. **Excessive Tardiness.** Excessive tardiness by the Parent in submitting full tuition payment will be grounds for Thunder to do any of the following: ban the Athlete from practicing, or competing, possible dismissal of Athlete from Thunder, or Thunder hiring a professional collection agency to collect any unpaid tuition and late fees.
- 11.4. **Termination Fee.** If this Agreement is terminated for any reason, including without limitation the Athlete quitting, insubordination, absences, tardiness, and late payments, Parent shall pay a termination fee of \$1000 to Thunder immediately after termination. If the Agreement is terminated for any reason, Thunder will not issue any refund to Parent for any amount paid under this Agreement.
- 11.5. **Liquidated Damages.** Parent acknowledges and agrees that any amount specified in this Agreement as payable by Parent upon breach or termination of the Agreement is not intended to be and will not be construed as a penalty. Instead, such amounts are agreed upon by the parties as a reasonable estimate of the damages that Thunder would suffer in the event of a breach or termination, given the difficulty of accurately estimating such damages. Therefore, Parent agrees that any such amounts will be considered liquidated damages, and not penalties, and shall be enforceable as such.
- 11.6. **Uniforms.** Athletes shall not wear their uniforms while engaging in inappropriate activities or behavior, as doing so would tarnish the reputation and image of Thunder.
12. **TRAVEL.**
- 12.2. Athletes shall not make their own travel arrangements without the information from Thunder Elite.
- 12.3. If the Athlete breaks any federal, state, or local laws while traveling with Thunder, they may be expelled from Thunder. Parent shall be responsible for arranging their travel back from the event.
- 12.4. Parent shall ensure that any family, friends, and supporters who wish to attend any out-of-state Thunder events will book their travel with the team travel package.

TERMS & CONDITIONS

Between Thunder All Star Cheerleading Inc. ("Thunder") and Parent (defined below). The registration, Payment Schedule, and the Terms and Conditions constitute the agreement between Thunder and Parent ("Agreement").

13. MISCELLANEOUS.

- 13.1. *Severability.* If any provision of this Agreement is invalid or unenforceable in any respect for any reason, the validity and enforceability of such provision in any other respect and of the remaining provisions of this Agreement will not be in any way impaired.
- 13.2. *Successors and Assigns; Third Parties.* All terms and provisions of this Agreement will be binding upon, inure to the benefit of, be enforceable by, and are solely for the benefit of the persons and entities signatory hereto, and will not create rights in any third parties.
- 13.3. *Representations, Assurances, Warranties and Covenants.* Each of the persons signing below represents, warrants and covenants that s/he has been duly authorized to execute this Agreement on behalf of the persons and entities for which s/he is signing.
- 13.4. *Jurisdiction; Interpretation.* This Agreement will be construed according to the internal laws of the State of Oregon.
- 13.5. *Rights and Remedies.* All rights and remedies of Thunder hereunder are cumulative and may be exercised singularly or concurrently. The failure of Thunder in any one or more instances, to enforce any of the terms of this Agreement will not be construed as a waiver of future enforcement of that or any other term.
- 13.6. *Non-waiver.* Thunder's failure or delay in exercising any right, power, or remedy under this Agreement will not operate as a waiver of any other provision or any subsequent application of the same provision. No waiver with respect to this Agreement will be binding unless executed in writing by the party against whom the waiver is asserted.
- 13.7. *Integration.* This Agreement contains the entire agreement between and among the parties regarding the matters set forth herein and is conclusive and binding on and inures to the benefit of executors, administrators, personal representatives, heirs, next of kin, children, successors, and assigns of each.
- 13.8. *Attorney Fees.* In case of action, arbitration, or any other proceeding, and any appeal therefrom related to or arising from this Agreement, the prevailing party will be awarded its reasonable attorney's fees together with costs, expenses, and disbursements.
- 13.9. *Force Majeure.* If performance under this Agreement is interfered with by acts of God, war, riot, embargo, acts of the Government in its sovereign capacity, labor difficulties, unanticipated unavailability of equipment or parts from vendors, or any other circumstances beyond the reasonable control and without the fault of the Party affected, such Party, on giving prompt written notice to the other Party, will be excused from such performance on a day-for-day basis to the extent of such interference (and the other Party shall likewise be excused from its performance), provided that the Party so affected shall use reasonable efforts to remove such causes of nonperformance and both Parties shall proceed whenever such causes are removed or cease.
- 13.10. *Notices.* All notices required under this Agreement shall be provided to the other party using the contact information set forth above, which may be updated from time to time. All notices and changes in contact information will be deemed given on hand delivery, confirmation of receipt of the delivery via electronic means, or 2 days after deposit in regular U.S. mail.
- 13.11. *Counterparts.* This Agreement may be executed in multiple counterparts, and the executed counterparts will constitute an integrated whole for the mutual benefit of all parties who have properly executed one of the counterparts. Transmission of a signed copy by electronic means by one party to the other parties shall constitute a valid signature.
- 13.12. *Dispute Resolution; Venue.* In the event of a grievance or dispute arising between the parties, they shall first attempt to resolve the issue through open and amicable communication. If that fails to resolve the dispute, either party may pursue legal action in Clackamas County, Oregon.




